There will be a brief pre-show meeting on Thursday September 29, 2016 at 7:00pm in the Equi-Plex clubhouse at Spruce Meadows. The delegate from each club must attend this meeting to receive vehicle and show passes on behalf of the Club and to submit all completed registration forms to Enthusiast Events' organizers. This requirement is to facilitate a smooth check-in for participants, as any vehicle that enters the facility without having completed the form will be ineligible to attend.
